The science

Australians are eating too much sugar

It is reasonable to single out sugary drinks for action

- Major source of added sugar intake
- Beyond energy, no nutritional value

Robust evidence of health risks associated with sugar intake and sugary drinks in particular

- Overweight and obesity
- Type 2 Diabetes
- Cardiovascular, liver and kidney disease
- Poor oral health







Mandate for action

"reasonable and increasing evidence that appropriately designed taxes on sugar-sweetened beverages would result in proportional reductions in consumption, especially if aimed at raising the retail price by 20% or more" (WHO Fiscal Strategies... 2016)

"Appropriately designed"

- Linked to evidence e.g. class of products applied to, amount of tax
- Framed as one in a suite of comprehensive measures
- Objectives carefully framed (+ measurable)

Sugar now an investment risk, says AMP

Sugar is becoming one of the biggest risks for investors in the global food and beverage industry, fund manager AMP Capital says.

Amid rising obesity levels and growing healthcare costs, a new report from AMP Capital says concerns about the sweet stuff have begun limiting growth for companies manufacturing and selling high-sugar products.

While the major parties in Australia do not yet have plans to introduce any form of soda tax, the public discussion generated by the possibility of a soda tax has the potential to reduce consumption given that it shines a spotlight on the issue and accelerates consumer education about the health impacts of sugar," the report said.

Definable class of products


Can be built into existing tax scheme
