# **Background to STARTTS**

STARTTS is a state-wide service funded by the NSW Department of Health and Commonwealth Department of Health to provide high quality assessment, treatment and rehabilitation services to people living in NSW who have experienced organised violence or trauma associated with the refugee experience. STARTTS is an Affiliated Health Organisation (AHO), a Non-Government Organisation whose services are deemed to be part of the NSW public health system.

STARTTS' service provision philosophy is predicated on a bio-psycho-social framework that incorporates a large range of clinical and psycho-social interventions informed by the latest advances in neuroscience and evidence based practice in relevant fields. As such, STARTTS provides a broad range of services including assessment; counselling for all age groups; psychiatric assessment and interventions; family therapy; group interventions; body-focused interventions such as massage, physiotherapy, acupuncture and pain management groups; support groups; programs for children and youth; and various strategies to increase the capacity of support networks and refugee communities to sustain their members.

The focus of the STARTTS' approach is on building capacity and empowering people and communities to take control over their own lives, using a strengths-based approach and building on individual, family, community and cultural strengths.

## Background to the Program Area of the Position

STARTTS' Neurofeedback Clinic was established in 2007 to provide EEG assessment and neurofeedback treatment to survivors of torture and trauma. STARTTS has found that the application of neurofeedback coupled with psychotherapy has produced positive results with a group of clients who have severe and chronic trauma responses. Neurofeedback has been used with children, young people and adults. The success of neurofeedback with clients experiencing chronic trauma responses is based on a developing understanding of brain activity, the impact of traumatic experiences on brain functioning, and the adaptability and plasticity of the brain. To support the ongoing development of this clinical service, STARTTS is currently expanding the Neurofeedback program to incorporate Biofeedback-based assessment measures and treatment interventions.

# **SELECTION CRITERIA:**

### **Essential Criteria:**

- 1. Relevant qualifications in Psychology, Social Work or other related fields.
- 2. Understanding of refugee issues, and the effects of torture and trauma on children and adolescents, their families and communities.
- 3. Demonstrated skills in providing assessment and therapy to children and adolescents.
- 4. Demonstrated experience and ability to advocate cooperate and liaise with school personnel including counsellors, teachers and parents.
- 5. Training and experience in Neurofeedback therapy or readiness to undertake further training and develop skills in Neurofeedback.
- 6. Demonstrated interest in applied neuroscience and/or use of neuromodulation techniques in working with children and adolescents.
- 7. Excellent oral, written and interpersonal communication skills and demonstrated ability to build and maintain effective working relationships.
- 8. Ability to work independently and as part of a multidisciplinary team within a multicultural environment.

### Desirable Criteria:

- 1. Current full registration with Australian Health Practitioner Regulation Agency (AHPRA) and eligibility for Medicare Provider number.
- 2. Current NSW Driver's Licence.

\*This position is considered child-related employment and will require a Working with Children Check and a National Police Check.

#### VACCINATION REQUIREMENTS

\*This role is a Category A role. It is mandatory for Category A workers to meet and maintain the vaccination criteria (as per the current NSW Health and STARTTS policies) including annual Influenza vaccinations. Two doses of an approved COVID-19 vaccine will be required to provide a record of your COVID-19 vaccination status. *If successful you must provide evidence of vaccination*.

Additionally, vaccination and/or assessment is required for Category A workers for the following transmissible diseases – measles, mumps, rubella, varicella (chickenpox), hepatitis B, diphtheria, tetanus, pertussis (whooping cough) and tuberculosis. *If successful you must also provide evidence of vaccination and/or assessment.* 

Should you not be able to comply with vaccination requirements before your commencement date, the offer of employment may be withdrawn.

If you have a medical reason for why you cannot be vaccinated, a medical contraindication evidence will be required.

## **BRIEF DESCRIPTION OF ROLE**

The main role of a Child and Adolescent Neurofeedback Specialist Counsellor is to provide assessment, counselling and neurofeedback therapy to children and adolescents from refugee backgrounds who are survivors of trauma. Using innovative techniques such as Neurofeedback, Safe and Sound Protocol (SSP), and Heart Rate Variability (HRV) this role will assist in alleviating the effects of trauma, fostering resilience, and promoting emotional and psychological healing in a supportive and culturally sensitive environment.

This role would also include liaising with schools, teachers, counsellors and other relevant professionals, while using STARTTS systemic approach in working with children and adolescents and their families. This role is also expected to participate in research and other relevant projects and to provide internal and external trainings related to neurofeedback, Safe and Sound Protocol (SSP) and Heart Rate Variability (HRV) and biofeedback.

### **PRIMARY OBJECTIVES:**

1. To provide clinical assessment, therapy, neurofeedback, biofeedback and other forms of neuromodulation treatment to children/adolescents referred to the Neurofeedback Clinic.

- 2. To develop, implement and evaluate assessment and treatment strategies within neurofeedback framework for working with refugee children, adolescents and their families.
- 3. To provide consultancy and training to the external service providers about the use of neurofeedback and biofeedback interventions in addressing psychological, cognitive and emotional difficulties of refugee children and adolescents.
- 4. To participate in the activities of the Australian Neurofeedback Institute (ANFI) program of STARTTS as required.
- 5. To liaise and work proactively with other agencies involved in resourcing and providing interventions to children and adolescents in a school setting.

## **PRIMARY DUTIES:**

## 1. Assessment, Neurofeedback Treatment and Counselling

- 1.1. Provide clinical assessments to children/adolescents referred to the Neurofeedback Clinic.
- 1.2. Provide therapy, neurofeedback, biofeedback and other forms of neuromodulation treatment to children/adolescents referred to the Neurofeedback Clinic.
- 1.3. Provide case management and advocacy to children/adolescents referred to the Neurofeedback Clinic when appropriate.
- 1.4. Liaise and work proactively with schools and other agencies involved in resourcing and providing interventions to refugee children and adolescents in a school setting.
- 1.5. Share knowledge, skills and expertise related to neurofeedback and biofeedback treatment with referring professionals and other service providers.
- 1.6. Collaborate and cooperate with Direct Services counsellors, youth team, school liaison officers, body focused therapists, and other staff at STARTTS while providing neurofeedback, biofeedback and other interventions to refugee children, adolescents and their families.
- 1.7. Undertake regular case review and follow-up of clients seen for neurofeedback or other forms of neuromodulation.
- 1.8. Within STARTTS Systemic BioPsycho-Social approach collaborate and cooperate with Direct Services counsellors, youth team, school liaison officers, body focused therapists, and other staff at STARTTS while providing counselling, neurofeedback, biofeedback and other neuromodulation treatment to children/adolescents referred to the Neurofeedback Clinic.

## 2. Training

- 2.1. Undertake relevant training on neurofeedback and applied neuroscience informed treatments for refugees survivors of torture and trauma.
- 2.2. Undertake training about the effects of torture and trauma and the approaches to service provision required for refugees who are survivors of torture and trauma.

## 3. Research and Evaluation

- 3.1. Participate in relevant research projects.
- 3.2. Participate in relevant evaluation studies.

## 4. Administration

- 4.1. Comply with the efficient recording and maintenance of client files and program records using CAReHR system.
- 4.2. Ensure that a minimum counselling workload consistent with the role is maintained.
- 4.3. Assist in the evaluation of the effectiveness of services provided.

## 5. Reporting

- 5.1. Prepare reports as required.
- 5.2. Maintain records of client related interventions and training and consultancy provided for other clinicians at STARTTS.

# 6. Personnel

- 6.1. Contribute to the STARTTS strategic planning process and report on relevant Strategic Plan Key Performance Indicators (KPIs).
- 6.2. Participate actively in the STARTTS Performance Management program and contribute to the development of an annual work plan that aligns with the organisation's Strategic Plan.
- 6.3. Be an active participant in team meetings to maximise contribution to the work of the team.
- 6.4. Participate in STARTTS staff meetings and other relevant meetings.
- 6.5. Work to ensure professional and co-operative working relationships within own team and with other departments across STARTTS.
- 6.6. Participate in identifying quality improvement initiatives/strategies.
- 6.7. Attend and participate in all training opportunities identified for the role.
- 6.8. Liaise with and seek senior advice as required.

### 7. As a STARTTS employee you are expected to:

- Have commitment to Human Rights, EEO, WHS and Safe Work Practices.
- Carry out the role and responsibilities in a manner that is consistent with delegations, policies, procedures and operations systems of STARTTS and in line with STARTTS Code of Conduct.
